

Small Business Rates Relief 2019/ 2020

Below are two tables, the first shows the rates payable from April 2019 by businesses able to claim Small Business Rates Relief who occupy a single property having a Rateable Value between £12,000 and £15,000, for the financial year 2019/2020. The second shows the percentage of relief available for each rateable value.

Since the 1st April 2017 businesses occupying only one property with a rateable value below £12,000 should be paying NO rates.

These figures are based on the Small Business non-domestic multiplier for 2019/ 2020 which has been set by central government at 49.1p to the pound. It may still be possible for some businesses to claim this relief back to April 2012.
